3. Bidding will be conducted in accordance with the **open domestic** bidding method contained in the Public Procurement and Disposal of Public Assets Act, 2003, and is open to all bidders.

All bids must be accompanied by a bid security of UGX 1,000,000 (or the equivalent amount in a freely convertible currency). Bid security must be valid until 20th November, 2017. Late bids shall be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below at 8(d) at 02:30 a.m. on 16th May, 2017.
