1. The Government of the Republic of Uganda through the National Identification and Registration Authority has allocated funds to be used for;

Procurement of Oracle Reinstatement and Support for One Year (Lot 1) and

Procurement of Oracle DBMS Enterprise Edition License Extension (Lot 2)

2. The Entity invites sealed bids from eligible bidders for the provision of the above supplies.
3. Bidding will be conducted in accordance with the open domestic bidding method contained in the Public Procurement and Disposal of Public Assets Act, 2003 (as amended), and is open to all bidders.
4. Interested eligible bidders may obtain further information and inspect the bidding documents at the address given below at 8(a) from 9:00 a.m. to 5:00pm.
5. The Bidding documents may be purchased by interested bidders on the submission of a written application to the address below at 7(b) and upon payment of a non-refundable fee of UGX 100,000/= . The method of payment will be by Bank Payment Advice Form issued by the Procuring and Disposing Entity with effect from 12th April, 2017. On presentation of proof of payment, the bidding documents may then be collected by the bidder from the address in 7(b) below with effect from 12th April, 2017.
6. Bids must be delivered to the address below at 8(c) at or before 11:00 a.m. on 12th May, 2017.

All bids must be accompanied by a bid security of **UGX 26,000,000 for Lot 2 and UGX 50,000,000/= for Lot 1** (or the equivalent amount in a freely convertible currency).

Bid security must be valid until 20th November, 2017. Late bids shall be rejected.

Bids will be opened in the presence of the Bidders' Representatives, who choose to attend at the address below at 7(d) at 11:30 a.m. on 12th May, 2017.
