1. The Government of the Republic of Uganda through the National Identification and Registration Authority has allocated funds to be used for the Procurement of 2,000 Laptop Computers
2. The supplies consist of 2,000 Laptop Computers.
3. The Entity invites sealed bids from eligible bidders for the provision of the above supplies.
4. Bidding will be conducted in accordance with the open domestic bidding method contained in the Public Procurement and Disposal of Public Assets Act, 2003 (as amended), and is open to all bidders.
5. Interested eligible bidders may obtain further information and inspect the bidding documents at the address given below at 8(a) from 9:00 a.m. to 4:00pm.
6. The Bidding documents may be purchased by interested bidders on the submission of a written application to the address below at 8(b) and upon payment of a non-refundable fee of UGX 100,000/=. The method of payment will be by Bank Payment Advice Form issued by the Procuring and Disposing Entity with effect from 12<sup>th</sup> April, 2017. On presentation of proof of payment, the bidding documents may then be collected by the bidder from the address in 8(b) below with effect from 12<sup>th</sup> April, 2017.
7. Bids must be delivered to the address below at 8(c) at or before 11:00 a.m. on 12<sup>th</sup> May, 2017.

All bids must be accompanied by a bid security of **UGX 160,000,000** (or the equivalent amount in a freely convertible currency).

Bid security must be valid until 20<sup>th</sup> November, 2017. Late bids shall be rejected.

Bids will be opened in the presence of the Bidders' Representatives who choose to attend at the address below at 8(d) at 11:30 a.m. on 12<sup>th</sup> May, 2017.
